INTRODUCTION

The Annual Synar Report (ASR) format provides the means for states to comply with the reporting provisions of the Public Health Service Act (42 U.S.C. 300x-26) and the Tobacco Regulation for the Substance Abuse Prevention and Treatment Block Grant (SABG) (45 C.F.R. 96.130 (e)).

How the Synar report helps the Center for Substance Abuse Prevention

In accordance with the tobacco regulations, states are required to provide detailed information on progress made in enforcing youth tobacco access laws (FFY 2018 Compliance Progress) and future plans to ensure compliance with the Synar requirements to reduce youth tobacco access rates (FFY 2019 Intended Use Plan). These data are required by 42 U.S.C. 300x-26 and will be used by the Secretary to evaluate state compliance with the statute. Part of the mission of the Center for Substance Abuse Prevention (CSAP) is to assist states¹ by supporting Synar activities and providing technical assistance helpful in determining the type of enforcement measures and control strategies that are most effective. This information is helpful to CSAP in improving technical assistance resources and expertise on enforcement efforts and tobacco control program support activities, including state Synar program support services, through an enhanced technical assistance program involving conferences and workshops, development of training materials and guidance documents, and onsite technical assistance consultation.

How the Synar report can help states

The information gathered for the Synar report can help states describe and analyze substate needs for program enhancements. These data can also be used to report to the state legislature and other state and local organizations on progress made to date in enforcing youth tobacco access laws when aggregated statistical data from state Synar reports can demonstrate to the Secretary the national progress in reducing youth tobacco access problems. This information will also provide Congress with a better understanding of state progress in implementing Synar, including state difficulties and successes in enforcing retailer compliance with youth tobacco access laws.

¹The term "state" is used to refer to all the states and territories required to comply with Synar as part of the Substance Abuse Prevention and Treatment Block Grant Program requirements (42 U.S.C. 300x-64 and 45 C.F.R. 96.121).

The chief executive officer (or an authorized designee) of the applicant organization must sign page one of the ASR certifying that the state has complied with all reporting requirements.

The state must upload one copy of the ASR using the online WebBGAS (Block Grant Application System). In addition, the following items must be uploaded to WebBGAS:

- FFY 2019 Synar Survey Results: States that use the Synar Survey Estimation System (SSES) must upload one copy of *SSES Tables 1–8* (in Excel) to WebBGAS. 

To minimize the risk of bias, the team split into groups and conducted simultaneous inspections. Throughout the inspection period, team members-maintained communication. In the event that one team issues a citation, all other teams are immediately notified. When the youth inspectors enter to an outlet had to observed if there's a conversation about the inspection. The youth inspector has to exit if there's a conversation and was postponed for the next days.

Merchant education and/or training

MHAASA's Regional Prevention Centers Staff visited 4,091 establishments to provide orientations to merchants about legislation that prohibits the sale, donation and distribution of cigarettes and other tobacco products including e-cigarettes to minors and the implications of law violations. The establishments included merchants' organizations such as: Walmart, Walgreens, Sam's Club, Costco, Supermax, etc. Fines and the mandated posters to be placed in all of their cash register conveyors.

The staff visited outlets listed by the Treasury Department as licensed vendors to provide orientation of the laws that prohibits tobacco sales to minors and the advertising if located within 500 ft. from schools. Also handling the appropriate new posters/stickers with information of current legislation alerting potential consumers on the prohibition of the sale of tobacco products to minors. Owners and clerks were advised on the fines and asked to be partner in promoting youth's health and wellbeing.

Community education regarding youth access laws

MHAASA'S staff partnered with the "Non-Smoking Day" of the Lung Association-Puerto Rico Chapter. They promote to be smoke free at the schools and the communities that they serve. They also promote the harm and danger of smoking and that it could be a good day to stop smoking and to get help. MHAASA staff participated at three radio programs during the "Non-Smoking Day" where it was discussed the harm and danger of smoking and promoted that it was a good day to stop smoking (WIPR, Radio Dimension and WKAQ). Community mobilization to increase support for retailer compliance with youth access laws

MHAASA consulted with the Department of Labor to obtain permission to contract minors for the Synar Study FFY 2019.

 On November 13, 2017 the MHAASA requested an opinion about contracting minors for the Synar Study from the Secretary of Labor, Attorney Carlos Saavedra.
 On December 5, 2017 the Department of Labor requested a copy of the last opinion issued in 1998 to be submitted to the agency by the MHAASA.
 On March 9, 2018 the Secretary of the Department of Labor sent a communication to the MHAASA denying permission to use minors for the Study of Tobacco Accessibility.

Agreement between the Treasury Department and the MHAASA to carry out Compliance Checks

1. On March 27, 2018 the Administrator of the MHAASA, the Assistant Administrator for Prevention and Promotion, and the Director of MHAASA's Federal Programs and Planning Office, met with the Secretary of the Treasury Department and his staff.

2. MHAASA staff brought to the Treasury Secretary's attention the importance of the warnings and the fines for sale of tobacco to minors and the importance of increasing enforcement to reduce such sales and to promote the practice of requesting ID's of youthful looking clients in the establishments that sell tobacco.

3. The requirements for all US states and territories to comply with the Synar Amendment was explained to the Treasury Secretary, and a dialog was held about the importance of the Study of Accessibility of Tobacco Products to evidence the percent of compliance found among establishments licensed to sell cigarettes and tobacco products.

4. The Secretary of the Treasury Department made a commitment to the MHAASA to develop a collaborative agreement to assign Internal Revenue Agents to each of the Prevention Centers during the Synar study for the purpose of developing an enforcement plan.

5. The Secretary of the Treasury Department assigned Internal Revenue Agents for the Synar Study so that, as undercover agents during these compliance checks, they can detect violations of the law and impose warnings on the businessmen at that time. 6. Before the implementation of the Synar Study, the Internal Revenue Agents, MHAASA staff, and the youth inspectors participated in the training related to the protocol to be follow during the simulations.

7. For the first time in the Synar Study, the MHAASA staff personnel and the Internal Revenue Agents imposed warnings on merchants who did not ask for identifications of the youth inspectors during the simulations.

Development of new posters on current legislation

New posters and stickers with information on current legislation were provided to the merchants. The main purpose was to alert to the potential consumers on the prohibition of the sale of cigarettes and other tobacco products including ecigarettes to minors.

Audiovisual Campaigns

MHAASA prepare two audiovisual campaigns. The title of the youth campaign was *"I decide to not smoke"*. The other campaign target was adults. The title was *"How much time you have left"*. Both campaigns were disseminated via social media (Facebook and Twitter), and the WIPR (the government tv-channel)

MHAASA Administrator and the Assistant Administrator for Prevention participated in an interviewed by the newspaper "El Nuevo Día" on September 30, 2018. The headline of the newspaper was "*New Fashion of Vaping with Nicotine*". Both spoke about the last steps of the FDA to control marketing and sale of ecigarettes. FDA has been working to direct actions to prohibit liquids flavors that are used in vaporizers and e- cigarettes known, as e-liquids. They also alerted parents about "Juuling", it's a device that looks like a USB.

MHAASA will create and maintain an Interagency Committee to implement a Tobacco Prevention Plan. The main objective is to develop and execute a Tobacco Prevention Plan for Puerto Rico directed by the agencies in charge of oversee the application of legislation related to protecting minors under 18 years of age from access to tobacco products. The committee will also develop more rigorous legislation in the prohibition of the sale of tobacco products to minors, and the development of a labor force aligned with the implementation of best practices for preventing the use of products derived from tobacco at an early age. It is expected that the first meeting of the Interagency Committee will be held during January 2019.

The committee will review public policy, check on prices of cigarettes and other products including e-cigarettes, analyze publicity related to e-cigarettes, vaping and new products in the market and identify strategies to reduce the accessibility and exposure of these products to minors. Committee will recommend the appropriate changes to policies, examples may include raising taxes on these products.

MHAASA's Regional Prevention Centers staff will continue merchant's education visits at least 70% of licensed merchants by the Treasury Department. Priority will be given to those businesses with higher violation rates such as, grocery stores, and gas stations. Merchants' education will include orientations on laws that forbid both, sales and advertising within 500' ft. of public and private schools. Educational materials advising that selling cigarettes and other tobacco products to minors is prohibit will be posted in visited locations. Incentives in form of letters or certificates will be awarded to merchants that comply with Synar compliance check. Merchant that not comply will receive a warning letter and educational packet with training materials, information about the fines that employee/business could face if they are caught selling to minors.

Due to Puerto Rico location on the Caribbean, people have to be prepared from June 1st to November 30th for storms and Hurricane's. On September 20, 2017 Puerto Rico received the most destructive hurricane María. Puerto Rico had flood, damage to road, and destruction to homes and establishment, lack of power and water. MHAASA's staff reported 1,061 establishments were not operating due to several reasons; licenses were not renovated reporting that licenses were too expensive, due to economic situation had to close, hurricane Maria destruction they had to close and seek for help to try to remodel.

Safety concerns on staff and youth's when the outlet is located in high-risk crime areas and are open for business after 8:00 pm. Instability in the Puerto Rico economy (i.e. fiscal crisis, unemployment) continues to influence tobacco sales. Increase in family and personal stress may also be aspects that influence smoking. Businesses are feeling the effects of the economy; therefore, they are more willing to sell to minors to increase profit margins. MHAASA plans to continue its efforts and keeping awareness of this issue at the forefront with law enforcement, retailers and the community in general.

The sampling methodology used in this evaluation consists of systematic sample selection. This statistical method involves the selection of every k^{th} element from a sampling frame, where k, the sampling interval, is calculated as: k = population size (N)/sample size (n). Using this procedure each element in the population has a known and equal probability of selection. This makes systematic sampling functionally similar to simple random sampling. It is however, more efficient (if variance within systematic sample is more than variance of population) and much less expensive to carry out (Daniel, W. 1995).

The sampling frame includes over-the-counter (OTC) outlets and vending machine outlets (VM). From the sampling frame, a starting point is chosen using a random number generator, and thereafter outlets are selected at regular intervals. The systematic sample of outlets is selected to conduct the study across areas of the island represented by the 12 MHAASA Regional Prevention Centers. Each Regional Prevention Center provides prevention services to a predefined geographic region within the 78 municipalities that comprise Puerto Rico.

The youth inspectors enter the establishment selected in the sample list, with discretion they have to observe where are the cigarettes located and check if there are one of the following brands: Newport and Marlboro. Youth inspectors proceed to ask the sale clerk for a pack of cigarettes of one of the brands mentioned. Youth inspectors are not supposed to try to convince the clerk in any way beyond asking once for a pack of cigarettes. If there is a smoke shop in the sample, the youth inspectors should ask for an electronic cigarette.

5a. Describe the methods used to recruit, select, and train adult supervisors.

MHAASA'S Prevention and Mental Health Promotion Assistant Administration operates 12 Regional Prevention Center (RPC) throughout the island. Each RPC provides services to a predefined geographic region serving 78 municipalities. The manager of each RPC decided which staff of its center was the adult supervisor.

One staff member of the RPC supervised the youth inspectors at all times, but they never entered to the outlet when youth inspector was attempting to buy cigarettes. They were trained to provide transportation, locate the establishments, verify the locations, and supervise all inspections procedures.

When the retailer was found in violation of the law at the time of the inspection, the MHAASA personnel and the Internal Revenue Agents entered the outlet to give a warning.

All the Synar personnel (RPC staff, agents of the Puerto Rico Treasury Department and youth inspectors) were trained by the investigators and participated in role-playing exercises.

Since 1997 the Puerto Rico Secretary of Labor objected to the used of minors for inspections efforts. Once again, this year MHAASA request an opinion about contracting minors for the Synar Study to the Secretary of Labor. The permission was denied once again.

The RPC staff identified candidates for youth inspectors in their geographic region. The candidates shall be 18 years of age at the time of operation and should be youthful in appearance. Also, they will have good communications skills, capable of following specific and general directions, available to work after regular hours or weekends, and available to visit outlets from different municipalities in the assigned RPC. All the candidates must possess a valid identification card.

Staff from the RPC staff interviewed youth inspector candidates and submitted a listing of preliminary choices to MHAASA Prevention Tobacco Coordinator for a second interview. In the second interview, the Tobacco Coordinator assessed applicant's interest in participating in the study, verifying the candidate's physical appearance, verbal and writing skills and ability to follow instructions. After the selection was made, applicants had to comply with the agency contracting requirements.

At least one youth inspector was contracted by each RPC to conduct the random unannounced inspections as required. Youth inspectors were trained on the inspection protocol using written materials, verbal instructions, videos, role-play exercises, and data collection methods by the researchers.
